MONDAY, November 22, 2021; 5:34 P.M.

The Board of Trustees for the Town of the City of Bloomington convened in regular session in the Government Center Chambers at 5:34 p.m., Monday, November 22, 2021. The meeting was called to order by Trustee Mwilambwe.

Trustee Mwilambwe directed the Township Clerk to call the roll and the following members of the Board answered present:

Elected officials present: Deborah L. Skillrud, Supervisor, and Steve Scudder, Assessor.

Staff present: Leslie Yocum, Township Clerk.

Action and Approval of Minutes of the October 25, 2021, Board Meeting, as presented.

Motion by Trustee Boelen, seconded by Trustee Becker, that the Minutes be approved as presented.

Public Notice of 2022 Meetings for the City of Bloomington Township and Evergreen Memorial Cemetery.

2021 Tax Levy Ordinance for Tax Year 2022 to be used in Fiscal Year 2023.

Motion by Trustee Crumpler, seconded by Trustee Emig, that the 2021 Tax Levy be approved and the Ordinance passed.

Trustee Boelen confirmed with Deb Skillrud, Township Supervisor, that the tax levy was a flat rate.

Trustee Mwilambwe directed the Township Clerk to call the roll which resulted in the following:

Ayes: Trustees Mathy, Boelen, Montney, Emig, Becker, Urban, Ward, Crabill, Crumpler, and Mwilambwe.

Motion carried.

Deborah Skillrud, Supervisor, addressed the Board. An update on the parking lot improvements was provided. Weather delays meant the remaining construction would be completed in the spring. The public could access the building through an alternate Americans with Disabilities Act compliant entrance. The Board was informed of an approved change order in the amount of \$9,800. Additional information would be provided at the Board's December 13, 2021 meeting.

Trustee Crabill requested Mrs. Skillrud explain the Community Emergency Response Program (CERP). He specifically questioned how funds were applied to various emergency assistance needs. Mrs. Skillrud provided a brief overview of recent assistance efforts and collaboration with the City for water payment shut off pledges. Additional Low-Income Household Water Assistance Program (LIHWAP) funds had been received. These dollars would be used before CERP funds as LIHWAP was designed for water bill assistance. The Township's assistance programs were referral based. The Township does not advertise its programs.

Trustee Crumpler questioned if the Township had received any applications for assistance from individuals affected by the flooding. Mrs. Skillrud stated Township provided assistance for utilities and rent only. Township staff had not questioned applicants if they suffered from this summer's flooding. The increase in applications was contributed to the various moratoriums being lifted.

Steve Scudder, Assessor, addressed the Board. All received complaints have been filed with the Board of Review and hearings have begun. The number of complaints were down this year. The Board of Review is anticipating an increase in complaints next year based on the number of homes sold in 2020.

Trustee Boelen questioned if the amount a home sold for above its value would contribute to an increase in the number of complaints. Mr. Scudder explained the assessment process and the impact of how a higher than market value sale price affected the Equalized Assessed Value (EAV) of a property.

Trustee Mwilambwe opened the meeting to receive public comment. Leslie Yocum, Township Clerk, reported that no one had registered to speak live or had submitted emailed public comment.

Motion by Trustee Boelen, seconded by Trustee Becker, that the meeting be adjourned.

Trustee Mwilambwe directed the Township Clerk to call the roll which resulted in the following:

Ayes: Trustees Mathy, Boelen, Montney, Emig, Becker, Urban, Ward, Crabill, Crumpler, and Mwilambwe.

SUBJECT: Request for Proposal (RFP) Professional Audit Services

RECOMMENDATION/MOTION: That the RFP for Professional Audit Services be awarded to Phillips & Associates, CPAs, P.C., for Fiscal Years 2022, 2023 and 2024 with an option of auditing financial statements for the Fiscal Years 2025 and 2026 at the request of the Township, at an annual cost to the Township and Evergreen Memorial Cemetery as listed in Appendix A. Fee Proposal and the Township Supervisor be authorized to enter into the standard engagement letter with Phillips & Associates, CPAs, P.C.

BACKGROUND: The Township issued an RFP for Professional Audit Services on November 12, 2021. The RFP was mailed to eight (8) local accounting/auditing firms. A Notice was published in the Pantagraph on November 13, 2021. The Notice was scheduled for publication on November 12th, the Township was notified via email of a power outage which delayed publication by one day. Two (2) firms sent emails to the Township informing us that they would not be submitting an RFP.

The deadline for submittal was December 1, 2021 at 10:00 a.m. At that time, the Township had received a lone RFP from Phillips & Associates, CPA's, P.C. The RFP was complete. This firm has served as the Township's outside auditor in the past. The firm is qualified and specializes in governmental audits.

BACKGROUND: The Township issued an RFP for Cleaning Services on November 20, 2021. The RFP was mailed to five (5) local cleaning firms. A Notice was published in the Pantagraph on November 20, 2021. Two (2) envelopes were returned to the Township citing not deliverable and one (1) additional vendor stopped by the office in response to the Pantagraph notice and requested a copy of the RFP. A walk-through of the premises was completed on November 30, 2021 at 11:00 a.m. with only one (1) vendor in attendance.

The deadline for submittal was December 3, 2021 at 10:00 a.m. At that time, the Township had received a lone RFP response from Soaring Eagle Cleaning Services, LLC. The RFP was complete. This vendor is currently serving as the Township's cleaning service.

The fees proposed for Calendar Years 2022 through 2024 are \$8,400 annually. This is an increase from the current annual fee of \$7,200. Soaring Eagle has provided cleaning services since 2017 at this cost. The Township researched current cleaning fees and costs and anticipated an increase due to the impact of COVID on cleaning supplies and labor costs.

Community Emergency Response Program (CERP): No report.

Workfare Programs: The Wellness Lifestyle Class was held via Zoom on November 5, 12 & 19, 2021. Eight (8) active GA clients are currently attending the classes. Topics discussed include immunity and seasonal wellness. Participants have the opportunity to ask specific questions and contribute to the overall discussion within the group. The class will continue to be conducted via zoom every Friday at 11:00 a.m.

Skills to Succeed remains on hold throughout the holiday season.

POTS Recycling: Owens Nursery and Florist delivered 16+ pallets of horticulture pots to the warehouse. The participants will determine if the stacked and sorted pots are clean before shipping to East Jordan Recycling Center in Michigan.

General Assistance (GA): Total November cases for GA is provided on the attached System Activity Report.

One hundred eight, (108), applicants sought Township services. This is a decrease of forty-seven, (47), from the previous month. Fifty-nine, (59), are *potentially eligible* for GA and 49, (49), are *potentially eligible* for Emergency Assistance, (EA). The decrease is due to Low Income Housing Water Assistance Program (LIHWAP) funding now available. Township is the payer of last resort.

No active Township clients presented new employment last month.

One, (1), client continues to be employed full time at Youth Build. One (1) client continues to be employed part-time in a work program through Heartland Community College. Five, (5), clients continue working part-time with National Able.

The Township received \$3,814 in Supplemental Security Income recovery funds from the State of Illinois in November.

COVID - 19 Update: The Governor announced a statewide indoors mask mandates for all residents regardless of vaccination status effective Monday, August 30, 2021. This mandate remains in effect. The state's corona virus metrics must be on a good downward trajectory before the Governor makes a decision to rescind. The Governor issued a Disaster Proclamation and Executive Order 2021 – 30 addressing COVID on November 12, 2021.

Illinois Housing Development Authority: (IHDA) - Round 2 of the Illinois Rental Payment Program was scheduled to open on Monday, December 6th. However, the start date was changed due to website issues. An additional \$297 million is available to renters and landlords. IHDA's program will cover up to eighteen (18) months of arrears and three (3) months going forward. Residents must have a court ordered eviction notice. Residents who receive Housing subsidies are included in this round.

We are grateful the City is now accepting Township pledges towards water bills for recipients who are eligible for Township assistance and are in disconnect status. Requirements are: 1.) resident must sign a waiver and 2.) resident must alleviate the remaining balance owed after Township pledge.

Low-income Household Water Assistance Program (LIHWAP) - On December 7, 2021, Governor Pritzker and the Illinois Department of Commerce and Economic Opportunity (DCEO) announced that \$42 million will provide assistance in shut-off avoidance for residents unable to pay their water and sewer bills.

TAZWOOD Community Services recently received funds for LIHWAP. The Township is payer of last resort and refers applicants to TAZWOOD for water bill payments.

Parking Lot Improvements: This project is not fully complete due winter weather conditions. A Change Order was required to split the North parking lot from the North entrance and northern portion of the East parking lot. On November 15, 2021, the North entrance, the northern portion of the East parking lot and handicap spaces were poured. The North parking lot will be delayed until spring 2022. Additional Winter Conditions & Fall Re-phase plus the Winter Shutdown expenses totaled \$10,150 + \$1,775 respectively. A separate credit Change Order for Silencure sealant, which will no longer be used in the spring, in the amount of \$3,900 was also issued. The total cost for these Change Orders is \$8,025.

Evergreen Memorial Cemetery (EMC): On December 18, 2021, *Wreaths Across America* ceremony will take place at 12:00 p.m. Afterwards volunteers will place a wreath on veterans' gravesites.

- We are finishing up Board of Review hearings this week.
- 2022 assessment work is beginning.
- We have 131 new construction residential permits that are open.

Going through our daily work of reviewing sales occurring in the City we are seeing an increase of low ratios. This means that the sale prices are higher than the assessments that we have on that property that sold. In valuing property, we use 3 years of the sales measured against the sale prices and make adjustments using the median of the ratio to adjust the assessments of properties using location or use of the properties. This is done because we do not adjust only the properties that have sold but all properties in a category or area because the sales are trending higher or lower.
