

MINUTES OF THE TOWN OF THE CITY
OF BLOOMINGTON TOWNSHIP
Monday, May 28, 2019; 5:45 P.M.

The Board of Trustees for the Town of the City of Bloomington met in the Council Chambers of the City Hall Building at 5:45 p.m. on May 28, 2019. The meeting was called to order by Trustee Renner.

Trustee Renner directed the Township Clerk to call the roll and the following members of the Board answered present:

Approval of Minutes of the April 22, 2019 Board Meeting, as submitted by Leslie Yocum, Township Clerk.

Motion by Trustee Mwilambwe, seconded by Trustee Painter that the Minutes of April 22, 2019 Meeting be approved as presented.

Motion carried, (viva voce).

Action and Approval of the Monthly General Town Fund, General Assistance Fund and Evergreen Memorial Cemetery Audits of April 2019 accounts as presented.

Motion by Trustee Mwilambwe, seconded by Trustee Painter that the Audits be approved as presented.

Approval of the General Town Fund, Anticipated Expenditures as presented and certified.

Approval to Rescind Cemetery Board Trustee compensation.

Motion by Trustee Black, seconded by Trustee Mwilambwe that the annual stipend be rescinded.

Resolution to Included Compensation Directed into a Retirement Health Savings Plan as IMRF Earnings.

Trustee Boelen questioned if these dollars would effect spending and accelerated payments. Deb Skillrud, Supervisor, addressed the Board. Dollars deposited would come from an employee's compensation and would not increase wages and/or pensions.

Steve Scudder, Assessor, addressed the Board. His report addressed Tax Rates. The formula was divide the Tax Levy by the Taxable Assessed Value which equaled the Tax Rate.

Deborah Skillrud, Township Supervisor, addressed the Board. The Township complies with Prevailing Wage requirements. An update was given to the Board regarding administrative changes. The Township received a dividend check in the amount of \$4,654 from TOIRMA, (Township Officials of Illinois Risk Management Association), insurance provider. The new Trustees were welcomed and Township staff was available to them. A PowerPoint presentation provided an update regarding the POTS, (Promoting Others to Succeed), program.

Trustee Bray arrived at 5:55 p.m.

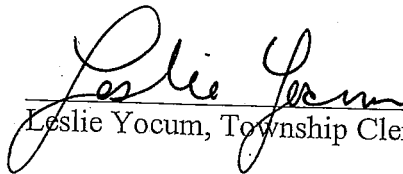
