Chairperson Painter directed the Secretary to call roll:

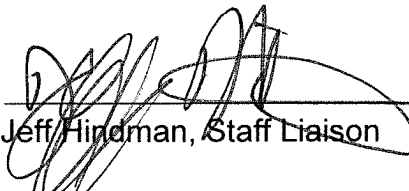
