Search for a Juneteenth guest speaker and talent has continued. Cultural Fest discussion postponed.

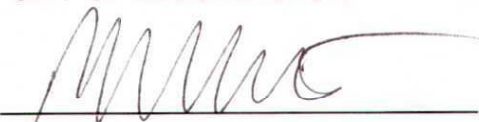
New Business
