MINUTES OF THE TOWN OF THE CITY
OF BLOOMINGTON TOWNSHIP
JANUARY 26, 2015

The Board of Trustees for the Town of the City of Bloomington Township met in the Conference Room of City Hall Building at 6:38 p.m. on January 26, 2015.

The meeting was called to order by Trustee Renner and the following were present:

Trustees: Kevin Lower, David Sage, Mboka Mwilambwe, Judy Stearns, Joni Painter, Karen Schmidt, Scott Black, Diana Hauman, Jim Fruin and Tari Renner.

Trustees Absent: None.

Also present were Staff: Renee Gooderham, Town Deputy Clerk; Steve Scudder, Township Assessor and Deborah Skillrud, Township Supervisor.

Staff absent: Tracey Covert, Town Clerk.

The Minutes of December 15, 2014 were presented.

Motion by Trustee Schmidt, seconded by Trustee Painter that the Minutes of December 15, 2014 meeting be dispensed with and approved as presented.

Motion carried (viva voce).

The audits for the General Town Fund, the General Assistance Fund, and Evergreen Memorial Cemetery for the month of December 2014 were presented.

Motion by Trustee Painter, seconded by Trustee Lower to approve the audits as presented and placed on file.

Ayes: Trustees Lower, Sage, Mwilambwe, Stearns, Painter, Schmidt, Black, Hauman, Fruin and Renner.

Nays: None.

Motion carried.

The General Town Fund anticipated expenditures were presented.

Motion by Trustee Schmidt, seconded by Trustee Painter to approve the General Town Fund anticipated expenditures.

Ayes: Trustees Lower, Sage, Mwilambwe, Stearns, Painter, Schmidt, Black, Hauman, Fruin and Renner.

Nays: None.

Motion carried.

Deb Skillrud, Township Supervisor, addressed the Board. She reminded the Board that February's meeting would include the Preliminary Budget. The Budget would be published on February 19, 2015 and included in the Township packet. She invited the Board to attend the McLean County Elected Official Meeting on Thursday, February 26, 2015. Invitations would be mailed. The meeting would be held at the VFW Post 454, 1006 E. Lincoln St. Bob Porter & Steve Mahrt of Ancel, Glink, Diamond Bush, DiCianni and Krafthefer were speakers. The topic was Creative and Cost Effective Solutions to Local Government Problems. She noted that Township was hosting the event.

Trustee Renner thanked Ms. Skillrud for her efforts with the Township.

Steve Scudder, Township Assessor, addressed the Board. He noted that the Board of Review finalized assessment changes December 2014. He stated that the Equalized Assessed Value (EAV) was adjusted ending just under five million dollars (\$5). He added that the numbers were down from previous years. He noted the page labeled The Board of Review Final Summary Breakdown had a negative or positive EAV factor applied. A factor of one (1) was applied.

Mr. Scudder noted that School District's report was listed by districts. He explained school districts were the largest portion of the assessed value. School districts included in the report were: District 87, Bloomington; Unit 5, Normal; Unit 16, Stanford/Olympia; and Unit 3, Tri-Valley. Corporate Tax Rates were compared with Unit 5 and District 87.

Trustee Fruin questioned the ten (10) year Historical Chart. Mr. Scudder stated same was obtained from the Annual Report. He noted that same would be placed on the website.

Trustee Fruin cited the importance of recognizing the City of Bloomington for efforts in assisting the Township and the other entities included on the tax bill.

Trustee Renner opened the meeting to Public Comment. No one came forward to address the Board.

Motion by Trustee Painter, seconded by Trustee Hauman to adjourn. Time: 6:42 p.m.
