DECEMBER 15, 2014

The Board of Trustees for the Town of the City of Bloomington Township met in the Council Chambers of City Hall Building at 6:38 P.M. on December 15, 2014.

The meeting was called to order by Trustee Renner and the following were present:

Also present were Staff: Tracey Covert, Town Clerk and Steve Scudder, Township Assessor.

Staff absent: Deborah Skillrud, Township Supervisor

The Minutes of November 24, 2014 Regular Session were presented.

Motion by Trustee Schmidt, seconded by Trustee Painter that the reading of the Minutes November 24, 2014 Regular Session meeting be dispensed with and approved as presented.

He addressed the 2015 assessment cycle. Field data had been gathered. The process went smoothly. He cited the Assessor Office's staff's support. 2015 was a quadrennial reassessment year. Visual updates were completed for all properties.

Trustee Schmidt questioned if the Assessor's Office would need additional staff due to the quadrennial reassessments. Mr. Scudder cited Mike Ireland's, former Township Assessor, preparations. The Assessor's Office also used GIS, (Geographical Information System), mapping and data collection. The process had been streamlined. He cautioned that additional staff may be needed during the process.

Trustee Renner opened the meeting to Public Comment. No one came forward to address the Board.
